## Waiver and Release Agreement

Please read carefully before signing this agreement.

This is a release of liability and waiver of certain legal rights.

In consideration for my being permitted to participate in the activities of Hawg Wild Ranch, I agree to the following waiver and release. I acknowledge that hunting and/or target shooting has inherited risks, hazards and dangers for anyone that cannot be eliminated, particularly in a wilderness environment. I understand that these risks, hazards, and dangers include without limitation:

1. The risk of handling firearms and being near others that have firearms in their possession.
2. The risk of injury from ammunition and shot from other guns
3. Walking in rugged country, including encounters with wildlife, animals and insects
4. Inclement weather conditions
5. The risk of injury riding on an all-terrain vehicle, or any vehicle used off the paved road
6. The risk of injury from the use of tree stands

I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss them with Brian Kelly. I understand that these activities may require good physical condition and a degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have the responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I am voluntarily using the services of Hawg Wild Ranch with full knowledge of the inherit risks, hazards and dangers involved and hereby assume and accept any and all risks of injury, paralysis or death. Lastly for myself, my heirs, successors, executors and subrogees, herby knowingly and intentionally waive, and release, indemnify and hold harmless Hawg Wild Ranch, their directors, officers, agents, employees and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorney fees) which are related to, limited to, negligence of any kind or nature whether foreseen or unforeseen. Arising directly or indirectly out of any damages, loss, injury, paralysis, or death results from negligence of Hawg Wild Ranch or from some other causes. I for myself, my heirs, my successors, executors and subrogees, further agree not to sue Hawg Wild Ranch as a result of any injury, paralysis or death suffered in connection with my use and participation in the activities of Hawg Wild Ranch.
